A deposit of \$50 is required along with a signed copy of this agreement. The balance must be paid in full the day of your outing (Cash, M/C, Visa, Discover, Check). You may increase the number of tee times, on a space available basis, up to 24 hours prior to your outing. **WAIVED per Greg**

Ellsworth Meadows will charge for a minimum number of golfers for shotgun starts. The minimum for a weekday shotgun is 90 golfers and there is a minimum of 125 golfers for Friday, Saturday or Sunday shotguns. Any outing using 71 or more carts must order carts one month before outing. These carts can only be ordered in allotments of 15 and will cost the outing \$55/cart (\$825 total). This cost is incurred from the golf car company.

Final meal count must be received by Ellsworth Meadows 7 days prior to outing. AFTER THAT TIME YOU WILL BE BILLED FOR THE NUMBER OF MEALS YOU ORDERED. In the event of golf rainouts, you will still be held responsible for meals ordered for that date.

All alcoholic beverages must be purchased from Ellsworth Meadows Golf Club, no exceptions!

Ellsworth Meadows maintains a dress code. All visitors are asked to please adhere to the dress code.

In the event of a rainout, rain checks will be issued to all players and will be valid for one year. Finally, if meals are a part of our agreement, you will be expected to honor the dinner or lunch commitment on the day of the event, regardless of the weather.
